Thermal Calculus and Condensation Risk Analysis

Building Regulations insist that a property be sufficiently insulated to ensure that it is both energy efficient and thermally habitable. Tasks, which are achieved by the correct selection of insulant of the correct thickness and situated in the correct position within a roof waterproofing system. EDS Roofing Supplies (Midlands) Limited offer through its Technical Services Department a free consultation service that can undertake and provide thermal calculations and condensation risk analysis, which upon examination can indicate the best method, type and thickness of insulant to use.



EDS Roofing Supplies (Midlands) Limited supply insulation from all the leading manufactures including the product a fire retardant insulation panel manufactured with a factory bonded high performance SBS or APP waterproofing membrane bonded to its upper surface (this type of insulation allows contractors to install roofing systems quicker, easier and ensures that any sudden or expected rainfall cannot damage any already installed insulation and roofing materials). Cut-to-Falls insulation schemes individually designed to provide a cost effective solution to removing standing water from a roof deck are available in all insulant formats: - polyurethane, mineral wool, polystyrene, extruded polystyrene and cork.

Site Surveys

EDS Roofing Supplies (Midlands) Limited through its Site Services Department can undertake free site inspections, which includes where applicable the taking and analysis of core samples from an existing structure. Reports in either verbal or written format are provided to ensure that the correct selection of waterproofing materials are used to ensure that not only a property being refurbished is thermally upgraded to comply with applicable Building Regulations but also that the most appropriate type of waterproofing materials are used to make the property resistant to the elements.



Specification Writing Service

EDS Roofing Supplies (Midlands) Limited provides through its Sales Department following accumulation of advice from both its Technical and Site Services Departments a free specification writing service. Specifications as standard are produced along NBS design to make for easy reading and allowing extracts to be taken and included in other documents, because of its flexibility EDS Roofing Supplies (Midlands) Limited can if required produce specifications to other formats if requested. Specifications for the manufactures EDS Roofing Supplies (Midlands) Limited represent in the UK are also available directly from The Royal Institute of British Architects through its own National Building Specification writing service.

Site Monitoring

EDS Roofing Supplies (Midlands) Limited through its Site Services Department can undertake free the monitoring of the installation waterproofing products. Reports in either verbal or written format are provided to ensure that the waterproofing materials used are installed correctly to both the requirements of EDS Roofing Supplies (Midlands) Limited and relevant Codes of Practice. The Site Services Department of EDS Roofing Supplies (Midlands) Limited operates a continual random monitoring of the workmanship of both Approved Contractors and Approved Installers during the installation of roofing products and following the installation of such products to ensure that Approved Contractors and Approved Installers maintain the necessary expected standards.

Approved Contractors and Approved Installers

EDS Roofing Supplies (Midlands) Limited has registered a number of Company's and Individuals strategically located across the United Kingdom who are classified as being either an Approved Contractor in the case of a company or as a Approved Installer in the respect to the actual installer of waterproof membranes. In instances where a Manufacture's Insurance Guarantee is to be issued in respect to the installation of waterproof membranes, this is only available through an Approved Contractor. Who in turn ensures that an Approved Installer installs the products selected, thus ensuring that not only is a property protected from the elements with a high quality product, but that they are correctly installed.

JIGSAW Guarantees in excess of that applicable under the sale of goods are available for those waterproof membranes as supplied by EDS Roofing Supplies (Midlands) Limited whose manufactures participate in the **JIGSAW** guarantee scheme. **JIGSAW** guarantees for durations of up to 20 years are available from numerous roofing companies located throughout the United Kingdom.

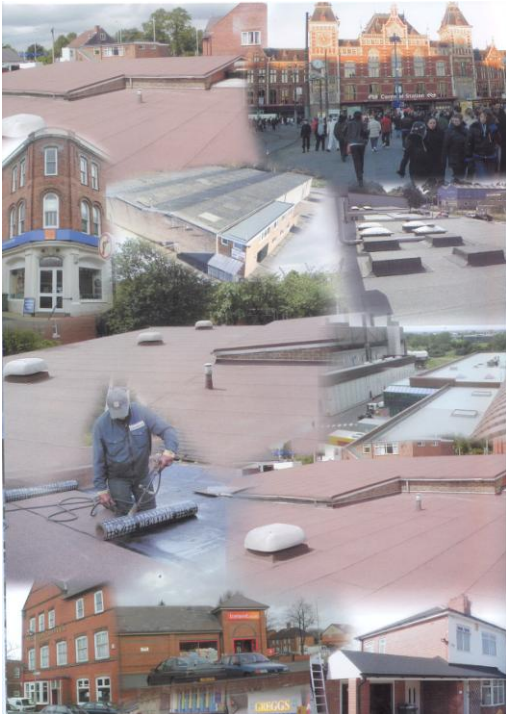
